Approved New Course with Contingency

Tabled Revised Admission Requirement (Form 1503)

• BS in Human Centered Design & Engineering
(The entire current catalog copy and proposed catalog copy should be on the form 1503. Early
Admission credits should be 39 if adding the CSE courses. Is it necessary to add the CSE courses to
Early Admission? Due to the similarity between the Early and Upper division requirements, does the
difference warrant having both? HCDE should have a continuation policy for upper-division admission.
Department should consider Direct Freshman Admission.)

Scott Winter is happy to consult with HCDE about this proposed change.

Tentatively Approved Revised Continuation Policy (Form 1503)

• BS Aeronautical & Astronautical Engineering (Number 4 will be changed to "....transferred out of the department." Number 5.a.2 will be changed to "A minimum grade of 2.0 in AA major courses."

Adam Bruckner will send the corrected policy to Chris Neils. There will be a vote by email to the CEP to approve the changes.

Select candidates for the Student Innovator: Teaching and the Student Innovator: Research awards
There were 3 nominations for Teaching and 3 nominations for Research. CEP selected the top 2 candidates in
each category. The CEP's first and second choices were provided to Alex Finlon, with comments. The Dean
will make the final selections.

Both of the Teaching choices are strong candidates with balanced nomination/recommendation packages (faculty + students).

The CEP selected two similarly qualified candidates for the Research award, and noted that both of them are senior to the third candidate and naturally have more publications and external recognition. However, the third candidate's engineering innovation is at least as strong as that of the two chosen candidates and it is expected that he will achieve this same breadth of recognition in the coming years. The student is still very early in his graduate program and we encourage the CEE department to re-nominate him in the future.
